

Oatley RSL & Community Club Limited Punters Club & Jackpot Terms and Conditions.

Oatley RSL Punters Club (ORPC) and Jackpot will take place every Saturday (pending number of entrants)

This Promotion is FREE to enter, to be eligible for the prizes, winner(s) will awarded on account of their tipping results and presence in the venue

*Members must be present within and inside the physical **Clubhouse at the scheduled start time of Sydney Race 7 and remain on club grounds until the conclusion of final ORPC tipping race of the day.*

***The Clubhouse refers to the physical club building only situated at 23 Letitia Street, Oatley NSW 2232 and is not inclusive of Club carparks, footpaths, driveways, adjoining halls, buildings or properties.*

No further draws will take place that evening if won.

Rules and Conditions

In addition to the Conditions set out by the Department of Gaming and Racing the following approved rules and conditions apply:

1. No entry fee is required to participate in the ORPC
2. Must have a minimum of five (5) participants to have submitted their tips in order for the ORPC to proceed
3. This is a "Members Promotion" thus the Participant must be a member of Oatley RSL & Community Club Ltd
4. Participants submit tips for the last five (5) races at both Sydney and Melbourne race meets.
 - a. In the event Sydney or Melbourne races are abandoned, Brisbane Races, then Adelaide Races will be substituted in.
5. In the event a participant's horse is scratched,
 - a. The Participant has the opportunity to change their selection with the Duty Managers approval any time before the scheduled race jump time.
 - b. If the participant does not choose a replacement the participant will be issued horse No. 1. If No.1 is unavailable, they will receive No.2 and so on.
6. Points will be awarded as follows:
 - a. Five (5) Points for a correct first place tip
 - b. Three (3) Points for a correct second place tip
 - c. One (1) Point for a correct third place tip
7. Prizes will be allocated according to the number of ORPC Participants on that particular day based on the highest score
 - a. In the event that more than one (1) participant has the top score, prizes for First and Second (and if necessary, Third) place will be split evenly between them
 - b. From five (5) up to and including nine (9) ORPC Participants
 - i. First place prize awarded only
 - a) First Place Prize consists of \$25 worth of Bonus Points
 - c. From ten (10) up to and including nineteen (19) ORPC Participants
 - i. First and Second place prizes awarded only
 - a) First Place Prize consists of \$50 worth of Bonus Points
 - b) Second Place Prize consists of \$25 worth of Bonus Points
 - d. Twenty (20) or more ORPC Participants
 - i. First, Second and Third place prizes awarded only
 - a) First Place Prize consists of \$100 worth of Bonus Points
 - b) Second Place Prize consists of \$50 worth of Bonus Points
 - c) Third Place Prize consists of \$25 worth of Bonus Points

8. In order to be eligible to claim prizes, the ORPC Participant must be present at Oatley RSL by the scheduled start time of Sydney Race 7 and remain on the grounds of the club until the conclusion of final ORPC tipping race of the day.
 - a. ORPC Participants are eligible to submit tips via phone or proxy, but must be present in the club by the scheduled start time of Sydney Race 7.
9. ORPC \$1000 Jackpot will be awarded to the ORPC Participant that reaches the Jackpot Points Target
10. The Jackpot will start at \$100 and increase by \$100 each week until won
11. The Jackpot Points Target will start forty (40) Points
12. Once the Jackpot reaches \$1000 the Points Target will remain at forty (40) points for two (2) weeks and then decrease by one (1) point each subsequent week until the Jackpot is won.
13. Multiple Jackpot Winners
 - a. In the event multiple ORPC Participants reach the Jackpot Points Target, the Participant with the highest points total will be the winner
 - b. In the event that multiple ORPC Participants have the same points total, and have both reached the Jackpot Points Target, the Jackpot will be shared evenly
14. The Jackpot Prize winner may choose one (1) or more of the following payment methods in any combination
 - a. Cash
 - b. Crossed cheque made out to the winning participant only
 - c. Electronic Funds Transfer to the winning participant only
15. Jackpot reset starting amount
 - a. In the event the Jackpot is won up to and including the first week at \$1000, the Jackpot will reset to \$100
 - b. Once the Jackpot has reached the \$1000 limit, the jackpot will continue to accrue as normal each week that it is not won. Once the Jackpot is won, the jackpot will reset to the current accrued total.
16. Senior management have the right in their sole discretion and without prior notice to alter the prize structure of the ORPC \$1000 Jackpot
17. Management reserve the right to refuse anybody entry into the ORPC at their discretion.
18. The following persons are not eligible to win the Oatley RSL Punters Club or Jackpot:
 - a. Any employee of Oatley RSL & Community Club Limited, either currently employed or employed within the previous 12 months of the date of the draw;
 - b. Contracted and sub contracted employees of Oatley RSL & Community Club Ltd, as well as their employees, including but not limited to Club tradesmen and the owners and employees of the caterer, whose services have been engaged in the previous 12 months of the date of the draw;
 - c. Suspended members, or any member with pending disciplinary actions against their membership;
 - d. Any non-financial member; and
 - e. Any member under the age of 18 years.
19. In the event the participant is an individual listed in clause 18 above, may participate but will not contribute to ORPC participant head count.
20. Directors, who act in accordance with these Terms and Conditions, are eligible to participate and claim prizes.
21. The promotion will run from 12th August 2023 to 31st December 2024
22. By accepting the prize, the member agrees to participate in any publicity arrangements made by or on behalf of the Club in relation to this promotion. Oatley RSL & Community Club reserves the right to publicise the winners' names and photograph through print, electronic media and broadcasts without permission or payment of any compensation to the winner and without prior notification.
23. Membership cards, numbers and entry tickets are not transferrable, and only the individual named and related to the winning membership number is eligible to claim the prize.
24. To the extent permissible by law, members release Oatley RSL & Community Club from any causes of action, loss, liability, damage, expense (including claim for legal expense), cost or charge sustained or in any way incurred, as a result of participation in this promotion.

Oatley RSL & Community Club in its sole and reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw.
